## Q & A SESSION

**Q: I lost my job because of the COVID-19 emergency, and I'm behind on my rent. Can my landlord evict me?**

A: No. If you are behind on your rent because of the COVID-19 emergency, the landlord may not evict you while the Order applies. Currently, the Order applies through May 17, 2020; it might be extended.

**Q: I have a section 8 voucher. How does the Order COVID-19 Executive Order apply to me?**

A: Your tenancy is governed by federal law – the new CARES Act. This federal law applies to evictions if your landlord gets federal assistance. The CARES Act prohibits evictions for non-payment of rent through July 27, 2020. It's a good idea to check with your caseworker. If your income changes because you lost your job, your rent payments may be lowered.

**Q: What if I am being evicted due to reasons other than failure to pay rent?**

A: If you are being evicted for a reason other than failure to pay rent, the Order does not apply to you.

## HOW CAN I REPORT HOUSING DISCRIMINATION?



If the discriminatory incident happened with the city limits of Tampa, call their Office of Human Rights and Community Services at (813) 274-5835.

If the discriminatory incident happened in unincorporated Hillsborough County, Temple Terrace or Plant City, File a complaint or call (813) 272-6554.

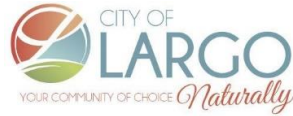
